- You are participating in a 2-day event for Junktique.
- **ALL FOOD VENDORS MUST BE REGISTERED NO LATER THAN AUG.15TH,2022. NO EXCEPTIONS.**
- All food vendors must provide Limited Liability Insurance.
- All food vendors must be register with the FREMONT COUNTY DEPARTMENT OF PUBLIC HEALTH & ENVIRONMENT **in addition** to submitting this Florence Chamber of Commerce form. You can contact Amy Jamison at (719)276-7361 (county) for assistance.
- A signed "Good Faith Pledge & Hold Harmless Waiver" must be signed and mailed in with application.
- Set up time is 6:00am till 7:30am. Take down is at 5:00pm on Saturday September 10th.
- Vendor Space may not be resold or subleased. Only one vendor is allowed per space.
- No refunds will be given for weather related problems or no shows. No refunds are given after your application has been accepted.
- NO Electricity is available
- Quiet Generators are allowed.
- **You must charge and collect the appropriate sales tax. You must also provide the Chamber office with your sales tax license with your application.**
- Portable Restrooms are ADA and available in the area.
- There will be a \$35 charge for any returned checks.
- Trash must be removed from assigned space and put into the receptacles, located on Main.
